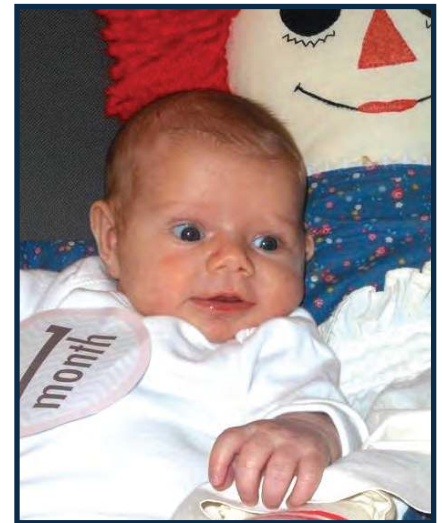
## Congratulations!
