Dealing with Soft Tissue Injuries and Insurance Companies

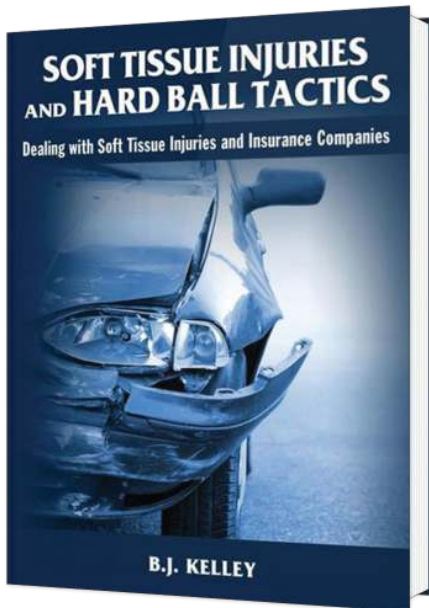
